A. Dave Knox Dedication

Mr. Root stated the Dave Knox has helped shape this district for the last 40 years and has moved this district forward over the last four decades. The street between the middle school and junior high school has been named in his honor.

C. Superintendent's Report

1. Financial Update

Mr. Root presented a 2005-2015 cash flow analysis and reiterated where we are at the end of August with a balance in all funds of \$5,075,217 and a balance in the Operating Funds of \$4,068,765. By comparison, at the end of August 2014, our balance in all funds was \$6,396,840 and in the Operating Funds was \$4,887,886.

Mr. Root presented a chart showing the tax rate compared to other cities.

2. Enrollment Report

Mr. Root noted that we are up 3 students over last year on the 6th day enrollment chart. The total number of students in the district is 1511, the highest ever. The district continues to benefit from controlled growth.

3. Old Band Uniforms

The old band uniforms will be given to the Band Boosters to potentially sell in the form of pillows or other items.

4. PARCC

Mr. Root noted the PARCC tests on Common Core standards which have not been fully implemented. He noted the test is flawed and not easy to take. 30% of students passed statewide. While we will not force students to take the test, we have to give it because it is tied to our federal funding.

5. Textbook Rotation

Mr. Root stated that we usually buy some new text books each year, we have not this year because they are not aligned with Common Core and the State has cut funding. We will be purchasing new math text books for K-12. The next series the district will look into purchasing is in Science or English/Language Arts.

6. Track Dedication

Mr. Root recommends dedicating the track to Mr. Williams at the end of year. Mr. Williams raised for the track and has coached our track athletes to numerous state appearances. The Board is very agreeable to this decision.



7. Sales Tax

Mr. Root showed a map of counties who have passed the sales tax.
